SHOW CAUSE NOTICE U/S 17

WHEREAS, Show Cause Notice is issued to the following Recognised Teacher Education Institutions (Total 362 TEIs of Annexure- A to I) Item No. 107 of the minutes of 325th (Virtual) Meeting of the NRC, NCTE held on 08th to 09th January, 2021, whom have not been issued Revised Recognition Order till date even after implementation of NCTE Regulations, 2014 due to non-submission of affidavits during 2015. These institutions (Total 362 Teacher Education Institutions) are directed to inform NRC as follows below:

1. Whether the institution has submitted affidavit to NRC for issuance of Revised Recognition Order. If yes, please submit proof of the same and if not, then furnish reasons of non-submission of the affidavit to NRC.
2. The institution has to submit whether they had submitted compliance with the conditions prescribed under Regulations, 2014 (Enhanced FDRs, Revised Staff Profile, Additional Built-up Area etc.) for consideration and decision of the Committee without issuance of Revised Recognition Order and after submission of affidavit from the list attached.
3. If the institution does not fall in any of above two categories, then institution is required to inform NRC about their status in respect of Revised Recognition Order compliance matters.

NOW, THEREFORE, Show Cause Notice under Section 17 of the NCTE Act, 1993 be issued to the institution to submit their reply (with supporting documents) accompanied with notarized affidavit of Rs. 100/- on Non-judicial stamp paper by the authorized representative of the Management within 30 days from the date of issue of show cause notice.

A list of complete total 362 TEIs is attached for circulation to all concerned listed institutions for compliance of the points of Show Cause Notice.

107. Consideration of the matter of Revised Recognition Orders (RRO)

Regional Director placed before the Committee, a list of 362 such institutions to whom RRO has not been issued till today due to not submission of required affidavit stating that institution will be comply with the conditions prescribed under Regulations, 2014, for consideration and decision of Committee.

The Committee discussed the matter in depth and decided to issue Show Cause Notice under Section 17 to institutions as per List put up before Committee for not making compliance to Regulations, 2014.

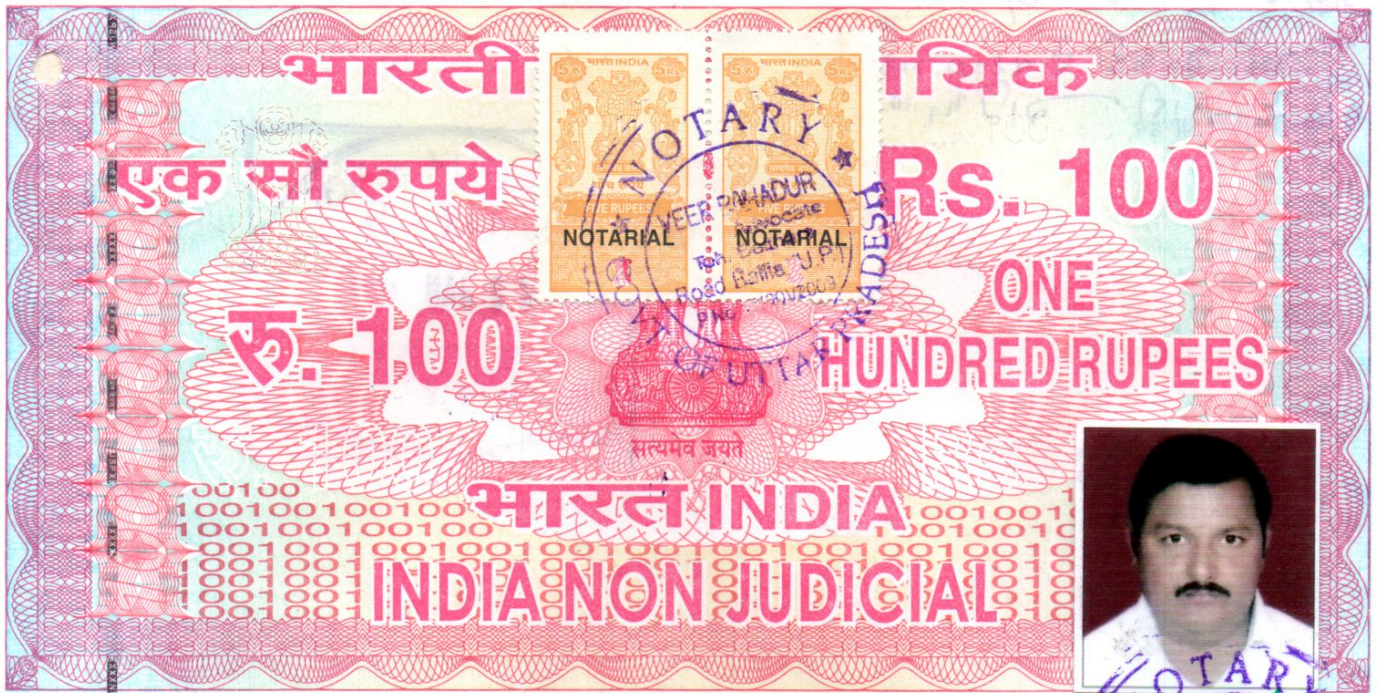

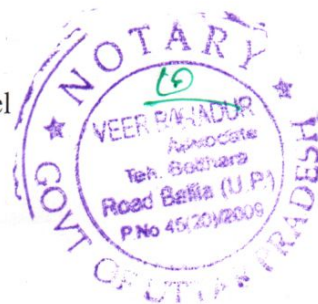

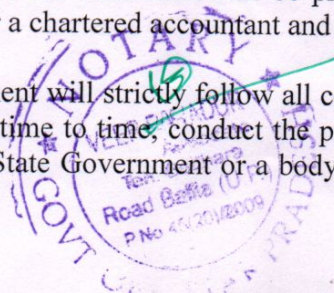

3. That out of the above mentioned land, the institution is in possession of minimum 2500 sq mts. (two thousand five hundred square meters) of exclusive well demarcated land for the initial intake of fifty students out of which 1500 sq mts (One thousand five hundred square meters) shall be the built up area and the remaining space for lawns, playfields etc.
4. That the land is exclusively meant for running the education institution. The entire land earmarked for the purpose of running the desired course is duly registered in the name of the institution through the society/Trust running the institution.
5. In connection with the application for grant of affiliation of B.Ed. Course with 100 intake the applicant hereby undertake to comply with the following:-
 - (i) That the management has seen, studied and understood the norms and conditions stipulated by the NCTE for grant of recognition and those of state government or a body or a person authorized by it, at the time of inspection, find any deviation from the prescribed norms/standards, we will accept any unfavorable decision resulting thereof.
 - (ii) That infrastructural, instructional and other facilities will be provided as per the NCTE/state Government norms, standards and guidelines prescribed from time to time.
 - (iii) That admission of students satisfying the eligibility conditions will be made as per the state government policy.
 - (iv) That there shall be reservation of seats for SSC/ST/OBC/Handicapped etc as per the Policy of state Government.
 - (v) That admission to the course will be made only after the affiliation is granted by the State Government.
 - (vi) That the supporting and other staff will be appointed as per the guidelines of the state government.
 - (vii) That the tuition and other fees will be charged at rates prescribed by the state government and shall not charged donations, capitation fees, etc. from the students.
 - (viii) That the academic and other staff of the institution shall be paid such salary as may be prescribed by the state Government from time to time.
 - (ix) That the management shall discharge the statutory obligations relating to provident fund, pension, gratuity etc. in respect of all its employees.
 - (x) That the Management will make adequate funds available for providing satisfactory facilities and for proper program me implementation.
 - (xi) That the account of the institution will be properly maintained and audited annually by the audit authorities or a chartered accountant and will be open of inspection.
 - (xii) That the Management will strictly follow all conditions and norms prescribed by NCTE/ State Government from time to time, conduct the program me in all earnestness and submit self to inspection by the State Government or a body or a person authorized by it as required at any time.



- (xiii) That the institution will provide a conducive atmosphere for academic and extra curricular activities and will prevent any mental and physical harassment of teachers and trainees.
- (xiv) In the event of Non. Compliance by the **Anchal Shikshan Sansthan, Vill. and Post-Pashuhari, Distt.-Ballia (U.P.)** with regard to the norms and standards and any other conditions laid down/prescribed by the state government from time to time. The state government or a body or a person authorized by it will be free to inspect at any time and take all necessary measures for effecting withdrawal of its recognition for permission, without consideration of any other issue and that all liabilities arising out of such a withdrawal would **Society** be that of the institution/management.
- (xv) That the management will not course or allow discontinuation of the course in any year or for any batch and that where compelled. It will seek the concurrence of NCTE/State Government for discontinuation on the completion of the year/batch.
- (xvi) That the course for which the affiliation is applied for is solely on self financed basis and we shall not claim any financial grant or assistance from the state Government.

I do hereby swear that my declaration under Para's (i) to (xvi) are true and correct and that is conceals nothing and that no part of this is tales. In case the contents of affidavit are found to be incorrect or false. I shall be liable for action under the relevant provision of the Indian penal code and other relevant laws.

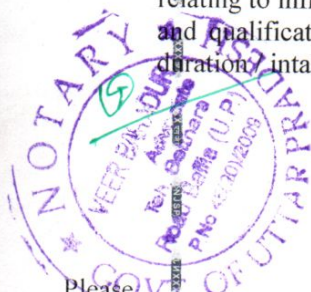
